The above paper products are produced with the following raw materials: PE coated paperboard.

According to our supplier's declarations;

- The paperboard complies with (EC) No 1935/2004 on materials and articles intended to come into contact with food and BfR Recommendation XXXVI. Paper and board for food contact.
- All the raw materials used in the extrusion coating complies with (EC) No 1935/2004 on materials and articles intended to come into contact with food and (EU) 10/2011 as amended by 2018/79 on plastic materials and articles intended to come into contact with food.
Substances used in the board extrusion coating do not contain any monomers or additives with specific migration limit (SML) according to Commission Regulation (EU) 10/2011.
The used substances in the extrusion coating do not contain any additives that are authorized as food additives by Regulation (EC) No 1333/2008 or as flavourings by Regulation (EC) No 1334/2008.

acidic, aqueous, fatty, alcoholic, dairy
- These cups are intended for use under the following conditions of temperature and time;
freezer/fridge, room temperature (up to 40°C for more than 24 hrs), hot fill (means the filling of any article with a food with a temperature not exceed 100°C at the moment of filling)
- These cups are not intended for use under the following conditions;
microwave oven, conventional oven
- These products are for single use only;
do not recommended for washing or reusing

The overall migration limit as well as the above restrictions and/or specifications are not exceeded when these cups are used under the conditions instructed here above for their use.

We certify that the product(s) listed above, do not contain Bisphenol A (BPA), PAA and Phthalates.

According to our supplier's declaration, all used pulps are elementary chlorine free.

These paper cups do not contain "Benzen" because there is no glue used in production. These paper cups are bonded only by heat and ultrasonic treatment.

- The above bio barrier materials used for production of these products is complies with the European Regulations (EC) No 1935/2004 and (EC) No 10/2011.
- The paperboard complies with (EC) No 1935/2004 on materials and articles intended to come into contact with food and BfR Recommendation XXXVI. Paper and board for food contact.
- All the fibers used in board products are covered by CoC certifications and the obligations of the European Union Timber Regulation (EU TR 995/2010) and Due Diligence System (DDS). The board products are manufactured from 100% virgin forest fibres. Main Species are Pine (Pinus Silvestris), Spruce (Picea Abies), Birch (Betula spp). All chemicals and additives used by supplier as downstream user fulfill the REACH requirements. They do not intentionally add any substances containing above 0.1% (W/W) of Substance of Very High Concern (SVHC) that will be published on the Candidate list. They continuously follow the development of the candidate list and the substances for authorization.

- Types of foods with which they are intended to be put in contact: dry, aqueous, fatty and non-fatty
- These plates are intended for use under the following conditions of temperature and time; the board is suitable as packing material both for dry and non-fatty foods as well as moist and fatty foods in direct contact with food at temperatures up to 90°C.
- These plates are not intended for use under the following conditions; microwave oven, conventional oven
- These products are for single use only; do not recommended for washing or reusing
